Deadline to co-sign: Thursday 25 August, noon (CEST)

The WHO published the [second draft of the updated Appendix 3](#) [1] of the Global action plan for the prevention and control of noncommunicable diseases (NCDs) 2013–2030 – also known as the NCD “best buys” and other recommended interventions. This second draft has addressed to a certain extent some of the concerns that NCD Alliance raised in our [response to the first draft](#) [2].

There will be an opportunity for a live informal consultation with non-States actors in official relations with WHO on 19 September 2022, for which a registration link will be made available on the [consultation webpage](#) [7] early in September.

Please note, that this submission is being shared with NCDA's NGO partners, full members and associate members only. We kindly ask that you do not share any further. We will also like to mention that this version is still subject to minor/editorial changes.
