The 72nd annual World Health Assembly (#WHA72) took place at the Palais des Nations in Geneva from 20-28 May. The NCD Alliance team was represented throughout the WHA and hosted several inspiring events. Here's our wrap up of the most important decisions taken by member states at WHA72 and their impact on NCDs.

Universal Health Coverage A72/12 &, A72/13, A72/14 &

WHA72 was dominated by the theme of Universal Health Coverage (UHC), as a cornerstone



11.8 Follow up on the NCD HLM

al = 152D

DG's Report - adopted

- Includes outcomes of Political Declaration from HLM
- 14 new commitments by Heads of State & Government => **Delivery Plan**
- Move to **5x5 approach** including air pollution & mental health
- **Progress report required by 2024**, for NCD HLM4 in 2025

Decision EB144/1 on HLM NCD follow-up - adopted

- Extend timeframe to 2030 for WHO action plans on NCDs & Mental health from 2020 to 2030 to align with 2025 goals & SDGs
- Requests WHO to **update Appendix 3 list** of recommended interventions to scientific progress and Requests additions to list for **mental health & air pollution**
- Requests DG to report to EB on progress on Global strategy to reduce harmful use of alcohol in 2020 & Obesity prevention in 2021
- ! Alcohol report WHO undertakes to fully engage Member States & consult
- Calls for increased resources to meet governments' increasing demand for technical assistance - link to WHO programme budget

Next steps:

- WHO report on NCDs with 4 important annexes (draft by Sept)

11.8 Follow up on the NCD HLM



NCD Alliance analysis:

- NCD report for EB/WHA 2020 & assignments to WHO go some way to keeping momentum from HLM, but reporting will continue to show off-track to meet 2025 targets & SDGs
- Excellent **Best Buys for mental health & air pollution** toolbox being developed soon
- Drafts due by 30 Sept 2019 but Air Pollution already behind schedule
- Report on **Global Strategy to Reduce Harmful Use of Alcohol** will show failure in 1st decade
- Discussion of way forward on alcohol harm will be hotly contested some Member States will advance idea of **Framework Convention on Alcohol Control** vs. producer countries
- Small increase (+5%) for NCDs in programme budget 2020-21, but NCDs will also benefit from big budget increase (+24%) for health systems strengthening
- Increasing attention (member state & NSA interventions, several side events) to fiscal measures - health levies/STAX - removal of health harming subsidies

BUT

- Not yet reassured on WHO accountability for delivering on NCD progress strong management & sufficient resources to meet government demand for support?
- Update broader toolbox of Best Buys all determinants & all NCDs
- Nothing on how to elevate voices of PLWNCDs, youth, marginalised groups



11.7 Access to medicines - Transparency resolution

- Roadmap on access 2019-2023 WHA noted A72/17
- Resolution on improving transparency of markets for medicines, vaccines & other health-related technologies - Adopted <u>A72/A/CONF./2 Rev.1</u>
- Proposed by: Italy, Andorra, Brazil, Egypt, Eswatini, Greece, India, Kenya, Luxembourg, Malaysia, Malta, Portugal, Russian Federation, Serbia, Slovenia, South Africa, Spain, Sri Lanka, Uganda
 - **Calls for: Governments** to share pricing & reimbursement information, to increase transparency of net prices of medical products (inclusive of rebates, discounts and other incentives)
 - **Governments** to share information on R&D costs & sources of funding, to make available results of clinical trials
 - WHO to support member states in collecting & sharing information on prices, reimbursement, clinical trial outcomes
 - WHO to monitor the impact of price transparency on affordability and availability of health products, incl effect on differential pricing, especially in LMICs and small markets, and provide analysis and support to Member States

11.7 Access to medicines - Transparency resolution

OP1 URGES Member States in accordance with their national and regional legal frameworks and contexts to:

1.1 Take appropriate measures to publicly share information on the net prices [FOOTNOTE] of health products;

FOOTNOTE: For the purposes of this resolution, net price or effective price or net transaction price or manufacturer selling price is the amount received by manufacturers after subtraction of all rebates, discounts, and other incentives.

1.2 Take the necessary steps, as appropriate, to support dissemination of and enhanced availability of and access to aggregated results data and, if already publicly-available or voluntarily-provided, costs from human subject clinical trials regardless of outcomes or whether the results will support an application for marketing approval, while ensuring patient confidentiality;

1.3 Work collaboratively to improve the reporting of information by suppliers on registered health products, such as reports on sales revenues, prices, units sold, marketing costs, and subsidies and incentives;

11.5 Universal Health Coverage



Primary health care towards UHC - <u>A72/12</u>, EB144/2019/REC/1, <u>Resolution EB144.R9</u>

- Summarises outcomes of the Astana Declaration from the Global Conference on Primary Health Care (PHC).
 - Strong health systems that emphasise PHC allow systems to respond to global challenges, address the main risk factors for poor health, the growing burden of NCDs, & help achieve UHC & the health-related SDGs.
 - The package of services offered through PHC should be tailored to local needs & priorities.
- The WHA adopted the draft resolution recommended by the EB in resolution EB144.R9.

Community health workers delivering primary health care: opportunities & challenges - <u>A72/13</u>, EB144/2019/REC/1, <u>Resolution EB144.R4</u>

- The report highlights the importance of a well resourced & trained health workforce, largely comprising community health workers in many countries.
 - Challenges faced by community health workers & sets out several opportunities & policy options to help ensure this critical component of many health systems is well-supported at all levels.
- The WHA adopted the draft resolution recommended by the EB in resolution EB144.R4.

Preparation for the high-level meeting (HLM) of the United Nations General Assembly on UHC - <u>A72/14</u>, EB144/2019/REC/1, <u>Resolution EB144.R10</u>

- The report presents the need to focus on achieving UHC & health system strengthening, in addition to continuing the existing disease-oriented focus of the health & development sectors
 - Outlines the main components of UHC & preparations for the first UN HLM on UHC
- The WHA noted the report & adopted draft resolution EB144.R10, recommended by the EB.



The report provides an update on progress towards achieving the health-related SDGs & summarises global & regional progress made by MS towards achieving SDG3, as well as progress made in implementing resolution <u>WHA69.11</u>.

- In the section on NCDs, the report notes, in particular, trends in alcohol consumption, tobacco use, & suicide.
- Other relevant sections on UHC, environmental risks, outcomes from HLM on NCDs, & plans for SDG3+ Global Action Plan.
- A comprehensive review of SDG indicators is expected in 2020.
- The WHA noted the report.

Key Messages:

- Strengthen health system to respond to the increasing burden of NCDs & multi-morbidities
- Accelerate action on addressing the risk factors for NCDs
- Facilitate multi-sectoral cooperation with non-health actors, taking into account conflict of interest

11.6 Health, Environment & Climate Change

Outcomes:

Member States agreed both documents under discussion:

- Draft Global Strategy on Health, Environment & Climate Change: the transformation needed to improve lives and wellbeing sustainably through healthy environments (A72/15).
 - Provides a vision and way forward on how the world and its health community need to respond to environmental health risks and challenges until 2030.
- Draft global plan of action on climate change & health in small island developing States (SIDS) (<u>A72/16</u>). Four strategic lines of action:
 - Empowerment (supporting health leadership in small island developing States)
 - Evidence (building the business case for investment)
 - Implementation (preparedness for climate risks, adaptation and health-promoting mitigation policies)
 - Resources (facilitating access to climate and health finance).

Member State Positions:

- Extreme weather conditions and infectious diseases of particular concern
- Balance adaptation and mitigation
- Reference to two regional documents: <u>Male Declaration</u> (South-East Asia) and The Strategic Action Plan to Scale Up Health and Environmental Interventions in Africa 2019-2029

Follow Up Advocacy Action:

- Emphasise links between NCD prevention and mitigation
- Urgency of protecting human health through mitigating & adapting to climate breakdown must be communicated at the June UNFCCC Intersessionals in Bonn & at COP25

12.3 Human resources for health

Documents:

- <u>A72/23</u> on international recruitment & migration of health personnel
- <u>A72/24</u> on progress made in the implementation of the WHO Global Strategy on Human Resources for Health: Workforce 2030.
- Assembly noted both reports.

Outcomes (relating to A72/24)

- Dr Tedros announced the appointment of Her Excellency Ellen Johnson Sirleaf, former President of Liberia, as Goodwill Ambassador for the health workforce.
- 40 Member States requested support to implement the global strategy
- Secretariat called upon all stakeholders to increase investment to advance this critical priority in order to realise UHC.
- Member States were encouraged to report their national data on human resources for health through an online platform.







12.4 Promoting the health of migrants & refugees

Draft Global Action Plan to Promote the Health of Refugees & Migrants 2019-2023 - Document A72/25

Outcomes:

- Member States agreed a five-year global action plan to promote the health of refugees and migrants
- Focuses on achieving universal health coverage and the highest attainable standard of health for refugees and migrants, and for host populations.
- lincludes short and long-term steps to mainstream refugee and migrant health care; enhance partnerships; strengthen health monitoring and information systems and counter misperceptions about migrant and refugee health.
- Report back on progress at the 74th World Health Assembly. Reports to the 74th and 76th World Health Assemblies will also include information provided by Member States on a voluntary basis, and UN agencies as appropriate.



Document: EB145/4

Sets out potential ways in which the participation of NSAs could be modified, including: 1) Limits may be placed on size of NSA delegations; 2) NSAs may be divided into constituencies to present their consolidated priorities prior or during Member State discussions, rather than delivering individual statement afterwards; 3) A World Health Forum could be held every 1, 2 or 5 years.

Member State Discussions and Actions:

- Current ways of operating are not satisfactory for Member States, nor for non-State Actors: ways forward must ensure that engagement is meaningful, relevant and efficient.
- Diversity of non-State Actors was recognised.
- Brazil requested clear specification as to the scope of the web-based consultation with non-State Actors which will inform the report, and for an in person consultation of Member States in Geneva.
- Dr Tedros noted the benefits of engaging with civil society, for example throughout the WHO Civil Society Working Group on NCDs.
- Secretariat will provide an updated proposal to the Executive Board in January.

Summary of NSA Positions:

- 5 NSAs delivered statements: Medicus Mundi International, IBFAN, IOGT International (Supported by NCDA), UN Foundation, UICC
- Geneva Global Health Hub Analysis here
- Watch this space & participate in hopefully forthcoming consultation/s

Key messages from joint statement with IOGT International (<u>LINK HERE</u>):

- 1. Differentiate between different groups among non-state actors and tailor engagement mechanisms accordingly
- 2. Conduct national civil society consultations with Member States ahead of WHO governing body meetings
- 3. Joint civil society interventions are a challenge but we are willing to help find effective channels towards meaningful engagement
- 4. Institute proper, timely and transparent consultation hearings with maximum participation of WHO and Member States
- 5. Conduct a well promoted and widely accessible web-based consultation for improving the involvement of civil society.

- 3-8 Feb 2020: **#EB146**
- 13-15 May 2020: **#PBAC32**
- **17-21 May 2020: #WHA73** start Sunday afternoon, close Thursday 21 May 2020 = 4.5 days including evening sessions, as compared to 8 days WHA72

Meaning...

- EB146 is extra important. Proposals for decisions / resolutions effectively need to be approved by EB no time at side of WHA for lengthy negotiation
- Fewer side events in shorter schedule?
- No changes to NSA engagement processes, but will be further discussed



Building the Ghana Advocacy Agenda of People living with NCDs

- 1 month online consultation to gather first hand information about priorities and challenges people living with NCDs including their care givers. 106 people responded to the survey.
- A 2 day national workshop for people living with NCDs across all the regions including govt officials, Parliamentarians, Civil Society (Local & International), Health Professionals, Academia etc 111 people participated.
- The aim was to provide a platform to those living with and most affected by NCDs to share their lived experiences, share priorities and provide recommendations and promote the meaningful involvement of people living with NCDs.
- The first draft was developed by the Ghana NCD Alliance and People living with NCDs and reviewed by NCD Alliance and other stakeholders



Launch of the Ghana Advocacy Agenda

- The Advocacy Agenda was launched via press conference
- About 50 media outlets covered the event
- Some of the headlines included
 - Ghana loses 94000 lives to NCDs every year
 - Treatment of NCDs to be captured under National Health Insurance
 - NCD Advocacy Agenda launched to prevent needless deaths
 - Govt to introduce Sin Tax to tackle NCDs
 - Govt target extra tax on alcohol, tobacco and beverages

Approach


- Community forums

- o Zero draft <u>circulated</u> on 21 May
- Negotiations began Tues 28 May
 - Likely closed to CSOs
 - Will be extremely difficult!
- Registration for HLM will likely go live in the next few weeks for approved orgs
