## **Update on the Political Declaration**

- Final draft text was circulated under silence procedure from Thurs 25 July - 6pm Mon 29 July
- Several delegations broke silence
   UN High-Level Meeting on Universal Health Coverage, 23 September 2019, New York
   just before the deadline on paragraphs 29, 68, 69 on SRHR, and
   paragraphs 70 and 71 on migrants

MOVING TOGETHER TO BUILD A HEALTHIER WORLD

Next steps:

- Co-facilitators will hold consultations with delegations and aim to have revised final draft under silence procedure shortly
- Aim is still to have final declaration agreed by end of July, otherwise it may get pushed to September (like 2018 negotiations on TB & NCDs)



## Update on the Political Declaration, cont.

- Overall takeaway is quite positive from an NCDs perspective
  - Balanced approach to prevention and treatment; continuum of care throughout the lifecourse
  - Promote healthy and active ageing
  - Community-based and people-centred health systems
  - Address the determinants of health (specifically mentions social, economic, and environmental)
  - Strengthen surveillance & data; improve routine immunization and vaccination capacities for CDs & NCDs
  - Recognition of addressing oral health and eye health [*though renal health is missing*], together with rare diseases and NTDs as part of UHC
  - Promote and improve mental health and well-being (linked to NCD burden)
  - Improve access to health services for persons w/disabilities
  - Promote healthier and safer workplaces
  - Eliminate financial barriers and ensure financial risk protection



## Update on the Political Declaration, cont.

- Implement policy, legislative and regulatory measures, including fiscal measures (recognises dual benefit of these policies, which is more ambitious language than 2018 PD on NCDs)
- Optimize budgetary allocations on health; Improve effectiveness of finance
- Prioritize PHC as cornerstone of health systems & strengthen referral system between other levels of care
- Paras 50 & 51 on access to meds, increasing transparency of pricing
- Engage all stakeholders and give due regard to addressing and managing COI and undue influence
- Build effective, accountable, transparent and inclusive institutions
- Strengthen legislative and regulatory frameworks & promote policy coherence
- Mainstream gender perspective on a systems-wide basis
- Impacts of climate change & other environmental factors on health, food security, clean air, WASH, etc.
- Follow up: HLM on UHC in 2023 in NYC

- Consultation to prepare report on first decade of <u>Global</u>
   <u>Strategy on Harmful Use of Alcohol</u> launched in June 2019
- **27-28 June:** Second WHO Forum on alcohol, drugs & addictive behaviours initial consultation.
- Consultation Timeline
  - August/September: WHO RCMs, NCDA outreach to members
  - October 21 November 4: WHO web consultation open with preceding discussion paper published on 21 October

## **2020 Japan Nutrition Summit**

- TOKYO 2020
- 2020 Nutrition Summit will be a Decade of Action and Agenda 2030 milestone
- Follows London 2013 Nutrition for Growth (N4G) Summit, coordinated by DFiD, coinciding with the London Olympics.
- London N4G commitments end in 2020, so Japan 2020 presents an opportunity for new and renewed SMART commitments for action and investment to be made..
- **5 thematic working groups** of stakeholders are supporting the Japanese Government developing the Summit agenda and goals, including proposing new commitments on
  - Making nutrition integral to **UHC** for sustainable development
  - Building **food systems** that promote healthy diets and nutrition, ensure livelihoods of producers and are climate-smart
  - Addressing malnutrition effectively in **fragile and conflict affected contexts**
  - Promoting data-driven **accountability**
  - Securing new investment and driving innovation in **nutrition financing**
- Private sector very relevant to improving nutrition, but complexities
- Future opportunities to review commitments, engage in associated campaign TBA
- Summit details likely to be announced in mid 2020 around the Tokyo Olympics, and the High Level Summit to take place late in 2020 in Tokyo.



# 1. SUMMARY

- 1. Vietnam's National Alcohol Act (NAA) has been in process since 2008 with the leadership of Ministry of Health (MOH)
- July 2017: National Assembly (NA) approved the MOH's proposal of NAA (1) Allowing the Government to develop "draft law on Preventing and Combating Harmful Effects of Alcohol and Beer"; (2) set deadline for NA approval through the 2-steps process 2018-19.
- 3. The alcohol industry attempted to intervene and influence the development and consultation process of this law, both directly and indirectly with 3-steps objective (1) Delayed process as long as possible (If have outputs); (2) No approval from any stage; (3) if approved: weaken as possible.
- 4. NCDs-VN has supported MOH since Sept 2017 and launched **advocacy campaign since May 2018** focused on (1) Highlighting WHO-best buys & public health interests at every process step; (2) Monitoring, informing public about alcohol industry interference; (3) Calling the state to block the industry intervenes; (4) raising public awareness on Alcohol Industry and country corruption.
- 5. NAA successfully passed and approved by NA but the has been weakened considerably compared to the first version released by MOH 15 April 2018;
- 6. Four lessons learnt from NCDs-VN advocacy process; action plan needed before the Act in effective fully 1 Jan 2020.


#### 2. Alcohol law in Vietnam: 15 Years Overview

# 3. Challenges: Alcohol Industry & supporters within the Government system & National Assembly

NO LAW; REJECT AT EVERY STEP OF GOVT'S & NATIONAL ASSEMBLY'S APPROVAL
 IF APPROVED: WEAKEN CONTENT AS MUCH AS POSSIBLE
 PUBLIC CAMPAIGNS TO STOP LAW PROCESS & DEFEAT PUBLIC HEALTH SUPPORTERS.





#### 3. Challenges (cont.): Who against alcohol law & their strategies?

1. EUROCHAM, HEINEKEN, Asahi Breweries, Asia Pacific International Wine and Spirits Alliance (APIWSA), Asia Pacific Business Association, The Wine maker federation of Australia (WFA), Japanese Sprits and Liquor Makers Associations (JSLMA), Euro-ASEAN Business Council (EU-ABC), International Association for Responsible Drinking (IARD), Vietnam Association of Alcohol and Breweries ...

- Submitted a letter of concern to country leaders (13 letters);
- Conducted media campaigns to **promote a positive image of the industry** and create more social acceptance of responsible drinking;
- **Discredited evidence published by MOH**, WHO, other Public Health science resources
- Prepared media messages for key supporters in Gov/ NA to voice at stakeholder meetings, public media


2. Key persons positioned in the Government & National Assembly System: (1) The Government (Ministries of: Finance, Industry & Commerce, Law and Justice, Information & Communication; National Committee for Transportation Safety, Prime Minister's office), (2) National Assembly (Commissions of Social Affairs, of Economics, of Finance & National Account, of foreign affairs, of Science, Technology & Environment, NA Newspaper, NA Television channel, Prominent NA members)

- to discredit the evidence published by MOH & WHO at stakeholders floor;
- to revise MoH's version towards AI's lobby strategies
- to discredit NCDs-VN and other local, international supporters to Public Health interests.

#### 4. NCDs-VN advocacy process May 2018 - June 2019

(1) keeping the **proposed law in line with WHO's best buys** policy to control alcohol;



#### 6a. Outputs (May 2018 – June 2019)

- Five campaigns with Five LoC to leaders of Vietnam (NA, Government and the Party);
- Three workshops to provide scientific evidence of alcohol related harms, present NCDs-VN perspectives on the last version of draft law and engaged victims of alcohol abuse in raising their voice about what they are suffering
  - a. Workshop with National Assembly delegation (Aug 29, 2018)
  - b. A press workshop (May 20, 2019)
  - c. A workshop to wrap up NCDs-VN's alcohol control law policy advocacy (July 18, 2019)
- **One community survey** to collect evidences of alcohol related harm in the community
- Attended 22 meetings/workshops organized by MoH, NA and Government;
- 70 articles written on mainstream and social media
- 15 television interviews
- Organized 8 chats on social media
- Collaborated with MoH and HealthBridge Canada to develop three factsheets with 1000 printed copies were distributed to more than 500 NA members
- Released a list of high-level officials and members who are pro-alcohol industry in Government and NA.



#### 6b. Outcomes

1) National Assembly session 6 (October 20th - November 18th 2018):

- Call out NA's members opposed to the proposed law and supportive of the Alcohol industry at the NA crucial meeting session Nov 16
- Contribute to significant change in outcome of NA meeting session 6: From "opposition to the GoV proposed law- Not approved" to "34 opinions in this final session with 3/4 of that are positive and supportive to the GoV's proposed law and fewer criticized opinions appeared in the overall discussion meeting".
- Public attitude changed positively via mass media in favour of public health: truth about the alcohol industry and its tactics to prevent the alcohol law highlighted



## 6b. Outcomes (cont.)

#### 2) National Assembly session 7 (May 20th - June 14th 2019):

- Contributed to the ratification of the law on alcohol related harm prevention (Alcohol Control Law) with 84,5% of National Assembly's members agreed on June 14th and will take effect on January 1st, 2020.
- Five recommendation letters of NCDs-VN were used by NA members during speeches in NA meetings to support for revising the proposed law towards MoH, WHO, NCDs-VN and against the alcohol industry.
- There were three progressive points serving as legal foundation to implement further actions to reduce the alcohol related harms in Vietnam.

1. Name of the law: Remained the MoH/WHO/NCDs-VN proposed name: "Law on Preventing and Combating Harmful Effects of Alcohol and Beer"

2. The rights and responsibilities of individuals and organizations in preventing alcohol related harms. This creates a legal basis for activists to raise their voices to the government and public to keep eye on alcohol burden

3. There are six items of Article 5 (Prohibited acts) that urge government and public to take urgent actions to reduce alcohol related harms

• NCDs-VN received a letter of appreciation from NA Committee of Social Affairs for contributing to alcohol control law ratification right after the NA meeting ended.



#### 7. Challenges/obstacles remained

- 1. The Act has been weakened:
  - No items specified alcohol tax policy;
  - No items make clear the role of CSOs, especially in monitoring and review law implementation
  - Budget for alcohol law implementation still depending on National Health Budget - Health promotion Funds linked with alcohol excise tax has not been mention
  - No specified punishment level (leaving for the Government's under-law guidelines)
- 2. The Alcohol Industry continues intervening
- 3. Key Al supporters in the GoV & NA persist
- 4. The revised excise tax has been delayed
- The preventive health system is under threat of widespread public-private partnership in health care while related policies are not well established
- 6. NCDs-VN need to be strengthened, especially human resources



## 8. Lessons learnt

1. **Designed various campaigns throughout the process** with key messages summarized in Letters of Concerns sent to all country leaders.

2. **Persistence of NCDs-VN** in ethics and beliefs: "Do not keep silent when knowing the truth"; "Always fight against evils including unhealthy commodity industries"; "the good wins the evil", "Always support for public health benefit and sustainable development"

3. A strong coordinating organization to promote alliance's collective action (having organizing, technical, communication, workforce and financial capacity)

4. A team of reputable multidisciplinary experts in public health, health economic, media and law

5. A strategic partnership with Ministry of Health: Created a continuous communication mechanism between MoH and NCDs-VN to monitor the process of law approval, shared vital information promptly, and responded immediately.

6. **Power of social media** (G-TV channel, facebook, liveshows...) and contributions of devoted journalists to deliver strong massages to policy makers and the public.

7. Timely warning with concrete example of alcohol industry interference through specific government/national assembly posts



# 8. Lessons learnt (cont.)

8. We built trusting partnerships with international organizations including GAPA, NCDA, IOGT-NTO Movement Sweden, and WHO

9. **Complimentary of some leaders** of Government, National Assembly and the Party encouraged NCDs-VN to conduct further actions.

10. **Integrating anti-corruption messages in advocacy** for alcohol control law by exposing typical individuals in the Government and National Assembly who are proalcohol industry.

11. **Timing and taking advantage of windows of opportunities** are also necessary. There were some tragic accidents caused by alcohol and we used this opportunity to deliver our strong messages about the harms of alcohol consumption and consequences impending the absence of a law to control alcohol consumption

12. Taking every opportunity to advocate together through strategically designed campaigns: Mobilise voices of PLWNCDs at stakeholders platforms (first time!); connected to international event PMAC2019 (voice on needs from Vietnam for building Framework Convention on Alcohol Control.
