# Description

The NCD Alliance (NCDA) and the Union for International Cancer Control (UICC) are offering an internship opportunity supporting the respective advocacy leads in our Geneva offices. This is an exciting opportunity to work in a respected civil society alliance, engaging with multilateral institutions and governments, on a priority global health and development issue.

The intern will support both the UICC and the NCDA Advocacy Managers in equal parts in their communications and advocacy activities engaging with our global and regional network, UN Permanent Country Missions, the World Health Organization and other relevant UN agencies in Geneva.

The intern will receive a stipend.

### **NCD Alliance**

Founded in 2009 and led by seven international NGO federations – Alzheimer's Disease International, the Framework Convention Alliance, the International Diabetes Federation, the International Union Against Tuberculosis and Lung Disease, Management Sciences for Health, the Union for International Cancer Control, and the World Heart Federation – the NCD Alliance is a unique civil society network working towards a world free from preventable suffering, disability and death caused by non-communicable diseases (NCDs).

# **Main Duties and Responsibilities**

- Support NCDA's and UICC's advocacy and communications work to maximise their impact on priority NCD-related processes and initiatives taking place in Geneva.
- Analyse NCD/cancer research, publications and reports, and summarise key messages and statistics for advocacy.
- Contribute to the preparation and drafting of policy and research papers, briefs, consultation responses, and advocacy publications.
- Draft letters to key decision-makers, Ministers, and other high profile figures.
- Support the researching and drafting of speeches and presentations for NCDA and UICC leadership.
- Draft articles and web stories for the UICC and NCDA's websites, e-alerts, social media platforms.
- Assist in the implementation of a new communications strategy to develop the International Cancer Control Partnership (ICCP) portal – www.iccp-portal.org
- Assist in preparations for the May 2015 World Health Assembly, including in the organisation of official side events, external briefings, member and partner meetings, and production of related background materials.
- Participate in the May 2015 World Health Assembly as a delegate; assist in on-site organisation of sideevents and note-taking at official sessions and side events.
- Provide administrative support, including arranging meetings, travel, taking minutes.

### Minimum requirements:

- EU nationality and/or the right to live and work in Switzerland without a work permit
- A Bachelor's Degree in public health, international relations or another relevant discipline
- Excellent proficiency in English (spoken and written). Knowledge of a second language is an asset
- Excellent team working skills
- Strong organizational skills
- Ability to work independently under tight deadlines and achieve results
- Entrepreneurial spirit and willingness to innovate
- Computer literacy in standard office applications (Word, Excel)
- Keen interest in NCDs and global health, and commitment to the NCD Alliance vision.

#### Desired skills include:

- Experience or background in policy, advocacy, communications, global health, development or related areas.
- Excellent research and analysis skills.
- Good communication skills, and ability to work with external partners and stakeholders.
- Excellent writing and editing skills.
- Knowledge and/or interest in global health and development.
- Knowledge and/or interest of the UN system.
