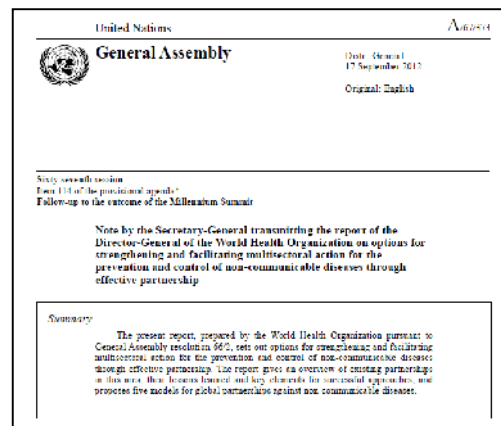
WHA NCD Resolution Three WHO Follow-up Processes

Requests the WHO Director-General to:

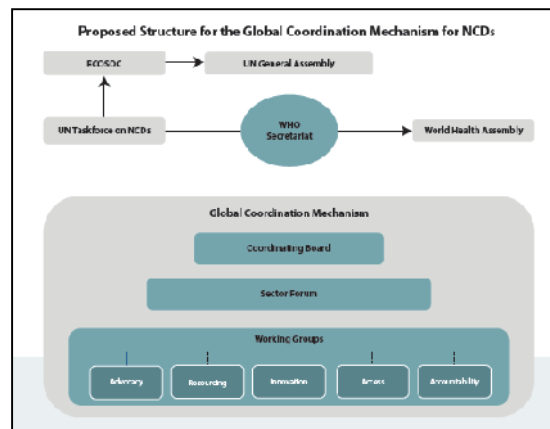
1. Develop terms of reference for a Global Coordination Mechanism(GCM) by November 2013
2. Develop a limited set of “action plan” indicators in 2013
3. Conclude work on division of tasks and responsibilities for UN organisations before end of October 2013

The Back Story Global Coordination Mechanism

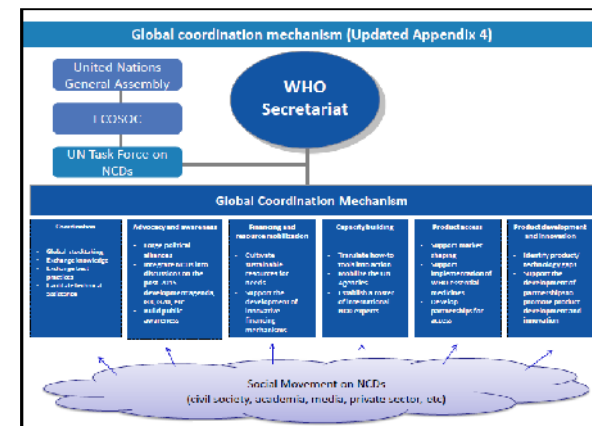
- Sept 2011: UN Political Declaration on NCDs
- 2012: WHO informal consultation / UN Secretary General Paper
- Mar 2013: GCM included in WHO informal consultations on GAP
- May 2013: GCM description included in endorsed GAP

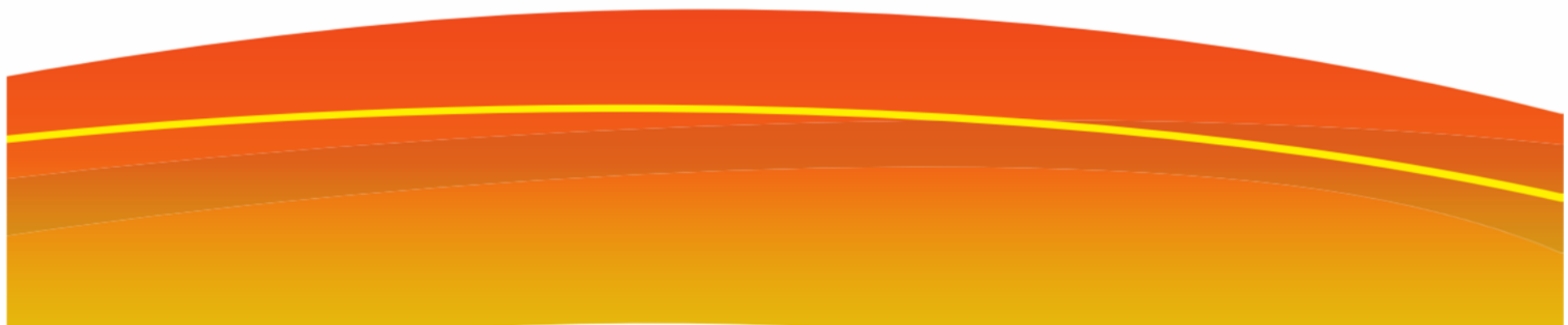

Global Coordination Mechanism Language Agreed at WHA

Purpose:

“To coordinate activities of the UN and promote engagement, international cooperation, collaboration and accountability among all stakeholders”

Principles:

- Convened, hosted and led by WHO
- Primary role/responsibility lies with governments
- Efforts of all sectors of society essential
- Facilitate engagement among Member States, UN, international partners, and non-State actors

Process to Date

May

27 May: WHA66.10 requests WHO Director-General to develop **draft terms-of-reference** for a GCM

July

23 July: WHO published first **discussion paper** for web-based consultation and Regional Committees

Aug

14 Aug: Informal dialogue with relevant **NGOs**
15 Aug: Informal dialogue with **private sector** entities

WHO Discussion Paper

Key Elements

Purpose:

“To improve coordination of activities which address functional gaps that are barriers to the prevention and control of NCDs”

Principles:

- Convened, hosted and led by WHO – report into WHO governing bodies
- Primary role/responsibility lies with governments
- International collaboration and cooperation

Functions:

- Capacity building
- Access to products/services
- Development of products /services
- Resource mobilisation
- M + E
- Stocktaking
- Advocacy + awareness

WHO Discussion Paper Key Elements Cont.

Participants:

- Member States;
- International Partners (UN agencies);
- Non-State Actors (NGOs, private sector)

Financing:

- WHO Programme Budget;
- Voluntary contributions from participants;
- Financial support from commercial sector consistent with standing WHO practices.

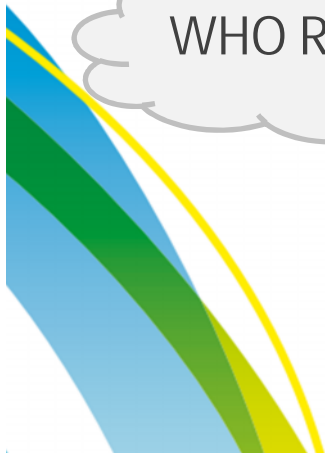

WHO Discussion Paper NCD Alliance Recommendations...

- Draw from lessons learnt
NCDnet...UN Road Safety Collaboration...PMNCH
- Be ambitious...think outside the box
- A clear value proposition / added value:
Clarity on focus, objectives and mission will determine success
- Action-oriented purpose:
"To coordinate partners to achieve the objectives in the Global NCD Action Plan 2013-2020 and the overarching "25 by 25" NCD mortality target"
- Shift from "functional gaps" to "strategic objectives"
Global advocacy and awareness; broker knowledge exchange; mobilise resources and facilitate technical support: promote accountability of resources and results

WHO Discussion Paper NCD Alliance Recommendations Cont.

- Coherent organisational structure – fit for purpose:
 - Coordinating Board – include member states/UN/NGOs..
 - Forum - ???
 - Working Groups – engage partners
 - Secretariat – in WHO, well resourced
 - Phased approach: GCM progressively built...
 - Consultation phase (2013)
 - Consolidation phase (2014)
 - Operational phase (2015-2025) – time-limited, with sunset clause of 2025 (Decade of Action on NCDs)

- **11-12:** WHO **Formal Member States** meeting finalise terms-of-reference (NGOs as observers)

2014

- **Jan-May :** Endorsed/adopted at WHO EB and WHA



GCM Consultation Call to Action

- Draw from/adapt NCDA's submission to WHO (available online shortly) to inform your submissions to WHO;
- Encourage network members to participate in the consultation - WHO Submission deadline, Oct 30th;
- Engage your government - ahead of WHO Regional Committee Meetings and November Formal Member State Consultations;
- Share intelligence on government positions on GCM

Measuring Progress: Action Plan Indicators

Resolution text (OP3.4):

- "A limited set of action plan indicators to inform reporting on progress"
- Applicable across the 6 objectives and three levels of stakeholders of GAP

Criteria:

- Based on feasibility, current availability of data, best available knowledge and evidence"
- "Minimise the reporting burden on Member States to assess progress made in 2016, 2018 and 2021"

Process:

- In consultation with Member States and relevant partners

Action Plan Indicators Consultation Timeline

Aug

- **12 Aug:** WHO Discussion Paper with Zero Draft set of action plan indicators
- WHO online consultation until **8 November**

Nov

- **13-14 Nov:** WHO Member State Meeting to finalise set of action plan indicators (NGOs as observers)

2014

- **20-25 Jan:** 134th Executive Board to consider indicators
- **19-24 May:** 67th WHA endorse the indicators

WHO Discussion Paper: Criteria for Action Plan Indicators

- Cover the six objectives of the GAP
- Feasible for use in all countries
- Availability of baseline data for all countries
- Existence of data collection tools
- Consistent with the 25 GMF indicators
- Assess progress made by Member States, international partners and WHO Secretariat
- Consistent with indicators for NCDs included in WHO Programme Budget 2014-2015

Proposed Action Plan Indicators

Number	Action Plan Indicator
1	Number of countries with an operational multisectoral national NCD policy, strategy or action plan that integrates several NCDs and shared risk factors in conformity with the global/regional NCD action plans 2013-2020
2	Number of countries that have an operational NCD unit/branch/department within the Ministry of Health or equivalent
3a	Number of countries with an operational policy, strategy or action plan to reduce the harmful use of alcohol
3b	Number of countries with an operational policy, strategy or action plan to reduce physical inactivity
3c	Number of countries who have implemented a complete indoor smoking ban and/or a complete tobacco advertising, promotion and sponsorship ban
3d	Number of countries with an operational policy, strategy or action plan to reduce unhealthy diet
4	Number of countries that have government approved evidence-based national guidelines / protocols / standards for the management of major NCDs through a primary care approach
5	Number of countries that have an operational national policy and plan on NCD-related research including community-based research and evaluation of the impact of interventions and policies
6	Number of countries with NCD surveillance and monitoring systems in place to enable reporting against the nine voluntary global NCD targets

Formalisation of UN Task Force on NCDs

Key Decisions

- Unanimous adoption of ECOSOC Resolution
- Total of 102 co-sponsors from all regions
- Decisions:
 1. Establish UN Interagency Task Force on the Prevention and Control of NCDs, by expanding mandate of UN Ad Hoc Interagency Task Force on Tobacco Control
 2. Task Force will support realisation of commitments in UN Political Declaration, in particular through implementation of Global NCD Action Plan 2013-2020
 3. Develop ToRs, division of tasks and responsibilities in consultation with Member States for adoption at ECOSOC's 2014 Substantive Session





UN Task Force on NCDs The Significance

Formal UN Interagency Task Force for NCDs:

- Convened and led by WHO
- Leverages a unified UN system response (24 agencies, growing)

- Reports to ECOSOC through the UN Secretary-General
- Builds on and incorporates the successful work and experience of the UN Ad Hoc Interagency Task Force on Tobacco Control
 - Well established system to assist countries
 - Rapid progress in implementing FCTC
 - Collaborative division of roles and responsibilities
- The UN NCD TF is likely to have strong linkages with a Global Coordination Mechanism for NCDs

UN Interagency Task Force on NCDs

Next Steps

Oct

- **2-3 Oct:** First meeting of formal UN Interagency Task Force to complete “zero draft” ToRs
- **13 Oct:** WHO Secretariat publish a zero draft Discussion Paper for **web-based consultation until 12 November 2013**

Nov

- **13 Nov:** WHO Formal Meeting with Member States to complete ToRs for UN Interagency Task Force, including division of tasks and responsibilities

July 2014

- **July:** UNSG include ToRs in report on the implementation of resolution for the consideration of ECOSOC in 2014.



UN Task Force NCDA Response / Call to action

- NCDA following consultations - meetings of UN Task Force in GVA;
- NCDA will consult with network and submit comments to WHO on zero draft of discussion paper when released mid-October;
- NCDA will share more info on CSO engagement in UN Task Force and the process (i.e. Formal Member State Meeting)

Why engage?

- Health and access to equitable health care and services a shared issue

Key Messages

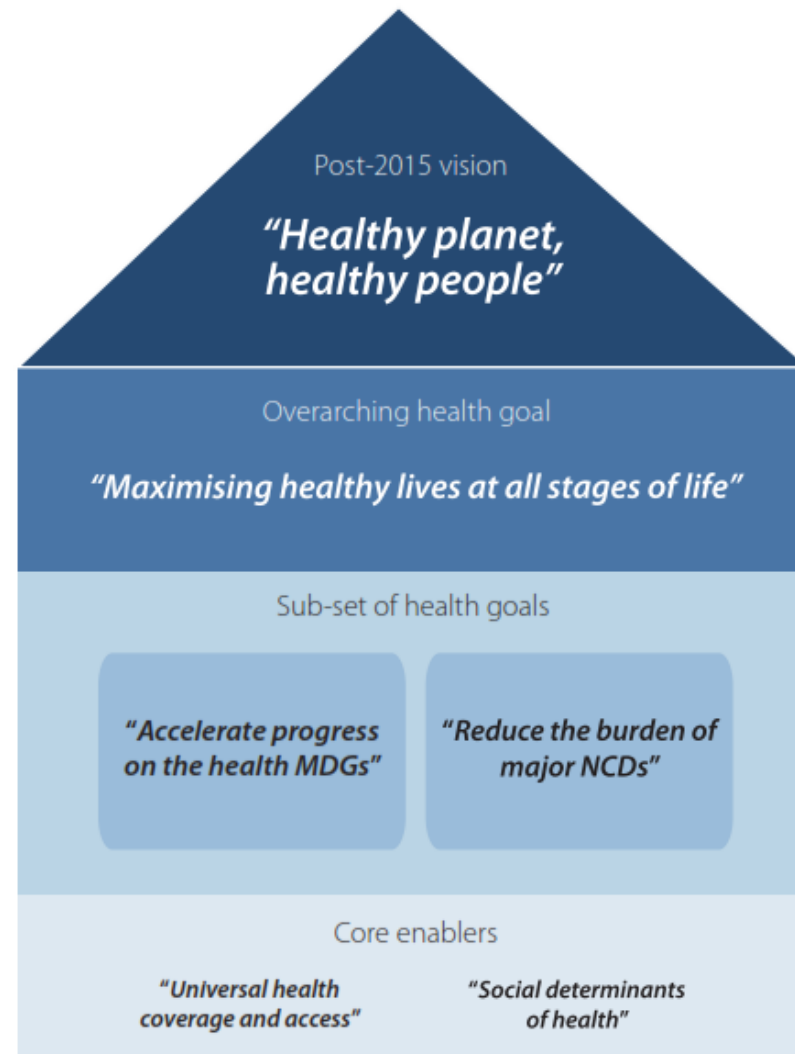
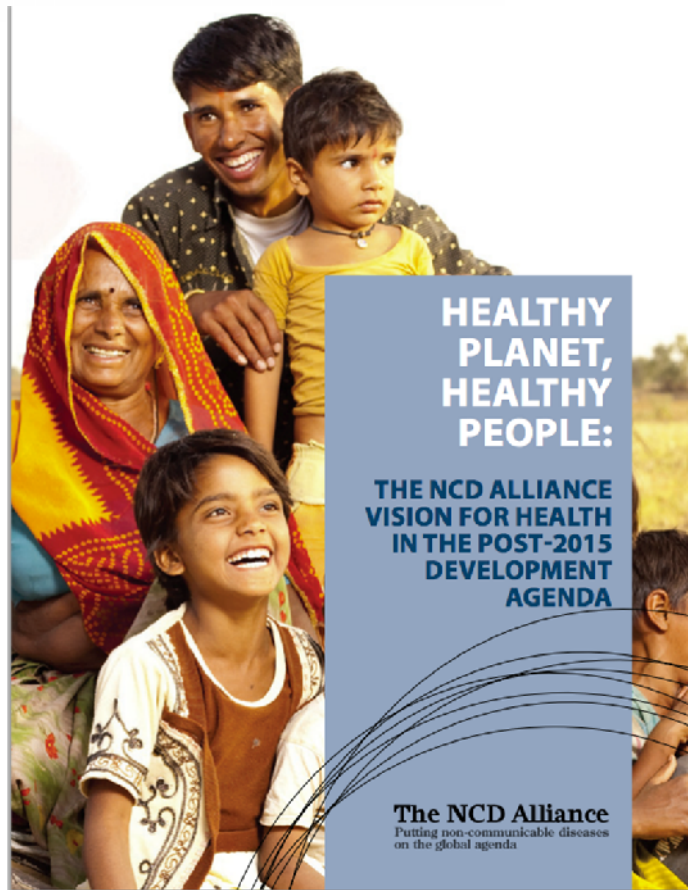
- Sustainable development as the "global guiding principle" for the post-2015 era

- Accelerate momentum on MDGs

- Provide clarity on the road map to 2015

Vision for NCDs in Post-2015 Healthy Planet, Healthy People



Key advocacy messages for September 2013

- Health must remain central to efforts to accelerate MDG implementation and in post-2015 sustainable development framework
- The future development framework must account for all health priorities, including NCDs
- Promote a rights-based, equitable, and lifecourse approach to health in global frameworks, that and reach the poorest and most vulnerable populations
- Developing multisectoral approaches to health in the post-2015 context

Importance for NCD community:

- Member States discuss how to adapt and tailor global NCD framework;
- Opportunity for Member States to:
 - Comment on the WHO Zero Draft Terms of Reference for the GCM for NCDs
 - Provide feedback on position of health and NCDs in the post-2015 development framework

NCDA Activity

- Coordinate NCDA representation
- Provide briefing with background information and key advocacy messages
- Deliver written/verbal statements for input into the discussions.

New NCD Alliance Program

“Strengthening Health Systems, Supporting NCD Action”

- Launched on 16 July at Economist Conference, SA
- First NCD Alliance program to support and build capacity of national NCD civil society
- Two year programme (2013-2014), funded by Medtronic Philanthropy
- Focus in 3 countries/regions: Brazil, South Africa and Caribbean
- Objectives: To build the capacity of NCD civil society, to monitor national progress on NCDs and advocate for improved NCD policies and the strengthening of health systems
- Capacity Building Grants: Award more than \$300,000 to local NCD partners

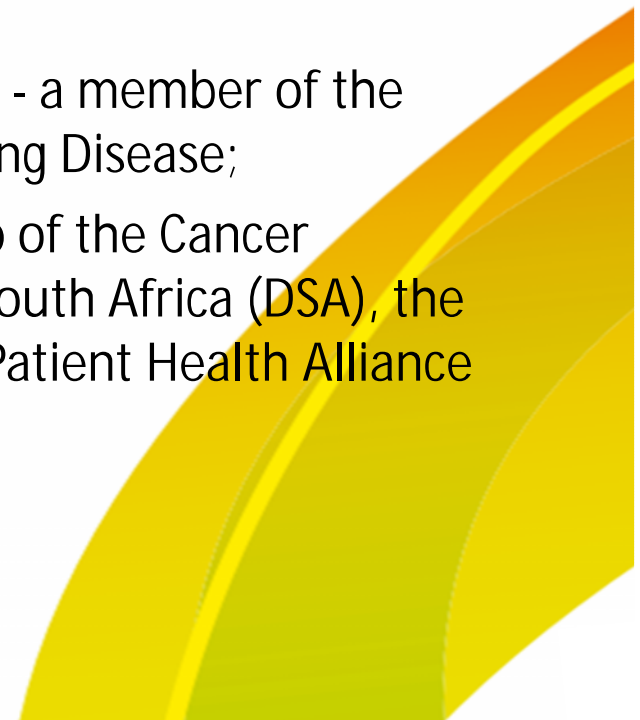


Strengthening Health Systems, Supporting NCD Action National Implementing Partners

- Competitive selection process for National Implementing Partners (NIP)
- One NIP per geography
- Eligibility criteria (e.g. member of founding federation)
- Announcement of NIP selection:
 - The Healthy Caribbean Coalition (HCC) - a member of the World Heart Federation (WHF);
 - Alliance for Control of Tobacco Use Brazil (ACT) - a member of the International Union against Tuberculosis and Lung Disease;
 - South African NCD Alliance (SA NCDA) made up of the Cancer Association of South Africa (CANSA), Diabetes South Africa (DSA), the Heart and Stroke Foundation South Africa, the Patient Health Alliance of Non-Governmental Organizations (PHANGO).
